Technical official's selection criteria & procedure

Background

The International Mixed Martial Arts Federation (IMMAF) defines sport technical officials as the following:

"Technical Officials are the constituent group of people identified by each International Federation who have the technical authority and qualifications to stage and administer the competition. Typically, Technical Officials include judges and referees in addition to the other sport specific officials. There may be both International and National Technical Officials depending on the rules and regulations of each particular sport".

National Technical Officials

As noted, there are two groups of Technical Officials recognised by IMMAF that will be involved in the delivery of each sport at competition time. National Technical Officials (NTOs) are defined as:

"Timekeepers, score keepers, judges and referees responsible for the application of the technical regulations in the conduct of each sport's competition. These officials are from "IMMAF Affiliated member Federations."

The aspiration of the Pan American Championships is to appoint NTOs from IMMAF Member Federations where they have suitable qualifications and experience. The appointments will be made in partnership with Federazione Italiana Grappling Mixed Martial Arts / Italian Grappling and Mixed Martial Arts Federation (FIGMMA) where the European Championships is being held.

Where a shortage of NTOs exists within the Member Federations, and as detailed in this policy, IMMAF will work in partnership with the Federazione Italiana Grappling Mixed Martial Arts / Italian Grappling and Mixed Martial Arts Federation (FIGMMA) throughout the process to identify NTOs. IMMAF Director of Regulatory Affairs, Mr. Marc Goddard, will then endorse all appointments.

NTOs fulfilling the following roles are required for the MMA competition:

Referees,

Judges,

Timekeepers,

Cut persons.

Experience and Qualifications

Qualifications

- IMMAF officials license certificate
- Recommendation letter from national federation

Knowledge and Competencies





- Be competent in use of the English language as per Article 4 of the IMMAF statutes.
- Display professionalism, integrity, and ethical conduct in their role as official.
- Ability to work collaboratively in a team orientated environment with other officials.
- Be able to accept instructions and respond appropriately to the direction of the IMMAF Technical Delegate Head Referee and those involved in competition management and delivery.
- Apply a range of communication strategies to develop effective partnerships, minimise conflict and deal with disputes effectively.
- Be able to relate and communicate appropriately with international athletes.
- Have physical fitness appropriate to the requirements of their sport/discipline.
- Demonstrate the ability to interpret data and perform efficiently in an environment with technical equipment and personnel.
- Ability to react quickly to changing circumstances in a high-pressure environment.

Selection Procedure

IMMAF will work in partnership with the Federazione Italiana Grappling Mixed Martial Arts / Italian Grappling and Mixed Martial Arts Federation (FIGMMA) to identify NTOs with suitable qualifications and experiences that meet the requirements of the role. This will be done through an open process of advertising and engagement with IMMAF Member Federations. All NTOs wishing to be considered will be required to register as an "official" at the Championships event page at https://www.mynextmatch.com/tournament/197/apply

Closing date for applications is Tuesday August 22nd, 2022.

All submitted applications will be sent to the Federazione Italiana Grappling Mixed Martial Arts / Italian Grappling and Mixed Martial Arts Federation (FIGMMA) and the IMMAF technical committee for ratification that they are in good standing with the sport and not subject to any current violations.

Thereafter, all ratified applications will be reviewed and shortlisted based on their experience, qualifications, and suitability for the role. This process will be managed by the following.

International Mixed Martial Arts Federation (IMMAF), Technical Delegate

Federazione Italiana Grappling Mixed Martial Arts / Italian Grappling and Mixed Martial Arts Federation (FIGMMA)Technical Contact

Successfully appointed NTOs will need to demonstrate their continued commitment to national and/or International MMA Competitions in order to ensure their Refereeing/Officiating skills and experiences are maintained.

If a conflict of interest is identified between the Technical Contact(s) and any of the NTOs being reviewed, IMMAF will work with that organisation to identify a suitable and appropriate alternative that will continue to support the process outlined above.

Appointed NTOs will be subject to final approval by the IMMAF Technical Delegate and the Federazione Italiana Grappling Mixed Martial Arts / Italian Grappling and Mixed Martial Arts Federation (FIGMMA). IMMAF will then formally appoint successful NTO's for the 2022 IMMAF European Championships by Monday 25th July 2022.





PLEASE NOTE:

- All selected NTO's must cover their own travel costs to competition arena and return home.
- A per diem of €20 EUR will be provided from 27th September to 1st October 2022.
- Shared accommodation will be provided including breakfast & dinner
- Closing date for applications is Tuesday August 22nd, 2022.
- Successful NTOs for the 2022 IMMAF European Championships will be notified by Tuesday 30th August 2022.
